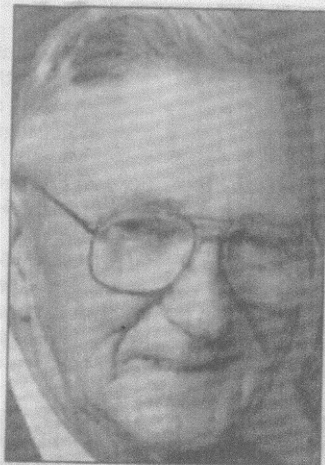
His parents; his wife on Nov. 2, 1998; and a brother preceded him in death.
