Fatal accident investigated

The Marshall County Sheriff's Office and the Marshall County Medical examiner Dr. David Bethel, are investigating a single-vehicle accident that occurred Dec. 24 at about 4:30 p.m.

The accident occurred on 330th Street approximately a half mile west of Laurel. The driver, identified as Jimmy Dale Harsha, 63, Laurel, was eastbound on 330th Street when he lost control and entered the north ditch. The vehicle rolled over, ejecting the driver who was not wearing a seatbelt. Mr. Harsha was pronounced dead at the scene.
