Robert J. "Bob" Jensen, age 73, of Marshalltown, Iowa died Sunday December 1, 2002 at Grandview Heights Care Center, Marshalltown, Iowa. FUNERAL SERVICES will be

He was raised and educated in the Oran and Fairbank areas, graduating from the Winthrop High School with the class of 1947. He attended Upper Iowa University in Fayette, and later served in the United States Army during the Korean Conflict from 1952 to 1954. On August 10, 1952, Bob was united in marriage to Marilyn Reck in Winthrop, Iowa. They moved to Independence where he began his career in the automotive business in December of 1954. In 1963, he opended Bob Jensen Ford in Jesup, and later partnered with Dwight Burkhart in 1967, forming Burkhart-Jensen Ford-Lincoln-Mercury in Marshalltown. In 1977, he became the sole owner of the dealership and began the operation of Jensen Ford-Lincoln-Mercury with his sons Kevin and Kendall, retiring in 1991. His memberships include the Trinity Evangelical Lutheran Church, Marshalltown Rotary Club, Frank-Lewis-Glick Post #46 of the American Legion, Marshalltown Chamber of Commerce, Iowa Automobile Dealers Association, and served as past member of the Board of Directors with Security Bank.
