Eva Elizabeth Milligan, 84, of Maxwell, died Monday, Jan. 21, at Mary Greeley Medical Center in Ames of cancer.

She was born March 19, 1917, in Lexington, Mo., to Millard and Louretta (Looney) Lowe. She moved to Iowa early in her life and graduated from the Maxwell High School in 1935.
